United Heritage Insurance Opens New Office Building

New building addition at corporate campus in Meridian features innovative solar energy design.

United Heritage Insurance has announced it will officially open a new office building that is partially powered (20%) by solar energy at its corporate campus located in Meridian's Central Valley Corporate Park on Monday, February 23, 2015.

A ribbon-cutting ceremony at the new building is scheduled for 11:00 a.m. The event marks the culmination of the company's 80th year in the life insurance industry; the company expanded in 2000 to add property and casualty insurance to its portfolio of insurance products.

The new 20,000 square foot, two-story building has been constructed incorporating an innovative solar grid system that is designed to generate up to 20% of the energy consumption in the office building with extensive use of other energy saving devices including LED lighting throughout.

Guest speakers for the ribbon-cutting on Monday will include corporate executives and board members, along with officials from the State of Idaho, City of Meridian, and Meridian Chamber of Commerce.

Press tours of the new building will be available to news media following the ribbon-cutting ceremony.
